

Litigation Specialization Certificate Requirements

The litigation specialization certificate requires that each student take a minimum of 10-Units from the courses listed below with a B- or better. Once the courses are completed in all four categories, please submit your certification form and your unofficial transcript requesting certification to the registrar. All litigation courses must be taken for a letter grade with the exception of externships. **** 1st STEP fulfills Trial Advocacy (Section 1) & Evidence in the Courtroom (Section 4) & Effective Brief Writing (Apply towards either Section 2 or 4).**

The course list may not be exhaustive; new courses are regularly added to the curriculum. Students are encouraged to email the Advisor with any questions after planning their courses (**not all classes are offered every term**). Approval of courses not listed is within the Advisor's discretion.
